PALINGEO AWARDED NEW STRATEGIC CONTRACTS IN THE INFRASTRUCTURE SECTOR, FOR A TOTAL OF EURO 14 MILLION

Carpenedolo (BS), 21 March 2025 – Palingeo S.p.A. (ticker PAL, hereinafter the "Company" or "Palingeo"), a leading company in the geotechnical and geognostic sectors, announces the award of three new contracts, which in total exceed 14 million euros, of which approximately 7 million euros relating to 2025 and the remaining part relating to 2026.

The interventions will concern the consolidation of strategic works, including motorway and railway projects of national importance, confirming the Company's ability to operate on several fronts in the field of major works.

Palingeo will be involved in the works for the Pedemontana Lombarda Motorway, in the execution of reinforced concrete diaphragms along Sections B2 and C, contributing to the construction of the infrastructure with targeted ground consolidation interventions. The project also includes related works and involves the use of advanced drilling equipment, necessary to ensure the safety and stability of the road structure.

In the railway sector, the Company has obtained two important assignments for the Verona-Padua HS/HC line, focusing on the Vicenza crossing. The first intervention concerns the construction of diaphragms for the Second Functional Lot, an area characterized by complex geotechnical conditions in an urban environment. The project involves the use of drilling technologies to ensure the stability of the track.

Palingeo will also be responsible for the installation of micropiles and foundation piles in several sections of the section, contributing to the construction of the support infrastructure for the new high-speed railway line. The works, commissioned by the Iricav Due Consortium, involve the use of advanced engineering methodologies for soil consolidation.

Leonardo Spada, CEO of **Palingeo**, said: "These contracts represent a significant step forward for our Company, both in terms of consolidation of technical skills and expansion in the market of major works. We will continue to invest in innovative solutions to ensure high quality standards and meet the increasingly complex demands of modern infrastructure."
